Project Description

According to the IADB, the objective is to increase public investment in infrastructure for the provision of goods and SSPP and equipment in TEs in Colombia. The specific objectives are: (i) to increase financing for urban and territorial development in TEs through financial support to the NDB; and (ii) to strengthen the capacities of municipalities to access financing for urban and territorial development, through support and improvement of the NDB.
