The aim of this project is to increase the number of unemployed, underemployed, or in vulnerable employment youth (18-30 years old) in Colombia that successfully starts or grow their businesses and create new jobs. The proposed model will consist of a partnership of ten chambers of commerce, which will be coordinated by the Confederación Colombiana de Cámaras de Comercio [Colombian Confederation of Chambers of Commerce] (CONFECAMARAS) and will support young low-income entrepreneurs (ages 18 to 35) in two main areas: advisory support for better business management and access to finance.
