According to the bank, the objective of the project is to contribute to the Capital District's economic growth and productivity, improving public transportation and the district's urban environment by developing and implementing the First Line of the Bogota Metro—Section 1. Its specific objective is to improve mobility and quality of life for Bogota's population through the First Line of the Bogota Metro, which will increase the capacity and improve the quality of transportation service and of the air—including a reduction in greenhouse gases along the metro corridor—as well as mobility and urban development integration by means of an efficient land use pattern that is more intense and diverse along the corridor.
