The objective of this Technical Cooperation (TC) is to support the Comision Intersectorial para la Atencion Integral de la Primera Infancia (CIPI) to consolidate a scalable version of Connect to Educate: A Multimodal Early Education strategy (CpE), aimed at providing remote (multimodal/multichannel) quality ECD services in rural areas or areas with limited connectivity. CpE will deliver educational content to children and their families and offer a remote learning/training solution for existing ECD workforce and preschool teachers. Through a first iteration cycle, Phase-I (CO-T1467) has conceptualized and developed a proof-of-concept version of CpE.
