Financial Intermediary: A commercial bank or financial institution that receives funds from a development bank. A financial intermediary then lends these funds to their clients (private actors) in the form of loans, bonds, guarantees and equity shares. Financial intermediaries include insurance, pension and equity funds. The direct financial relationship is between the development bank and the financial intermediary.

De acuerdo con el BID, la Fundación CRUSA es una organización privada costarricense, independiente y sin fines de lucro, que desde 1996 contribuye a la mejora en la calidad de la vida de las personas y el desarrollo sostenible de Costa Rica. Cuenta con patrimonio y personalidad propios, así como capacidad jurídica plena para ejecutar todo tipo de actos y contratos necesarios para cumplir su misión. Anualmente, la Fundación invierte alrededor de 4 millones de dólares de recursos propios en proyectos estratégicos. Además, desde el año 2010 ha ejecutado diversos proyectos financiados por el Banco Interamericano de Desarrollo (BID), con un promedio de US\$680 mil por proyecto, alcanzando un monto total de US\$3.42 millones
