## Project Description

According to the IADB, the General Objective of the first operation is to contribute to meeting electricity demand by improving the reliability and capacity of Ecuador's electrical system. The specific objectives are: (i) to preserve the reliability of electricity generation at strategic points of the National Interconnected System; (ii) to increase the quality and transmission capacity of the electrical grid for the integration of new energy sources; (iii) to contribute to universal energy access in the Ecuadorian Amazon Region; and (iv) to strengthen the sector's capacities to facilitate private sector participation and incorporate the concept of resilience into planning.
