### Project Description

The project will improve the competitiveness of Guyana's small scale farmers and promote their access to high value export markets. The project will finance the implementation of a cluster farming model which will help small scale farmers to achieve scale and also provide key marketing and agronomic services.

The MIF project will focus on developing a network of 20 new contract farms. Farmers who are interested in partnering with CADP will possess their own land, be able to secure access to finance (with adequate financial conditions) and be willing to adopt a series of quality and traceability standards. The project will focus on agriculture farms from 2 to 10 acres, which will grow hot peppers and other horticultural crops based on demand from buyers.

The project will be executed by CARANA Corporation, a member of the Palladium group of companies. CARANA is an international services contractor that has worked on other IDB, DFID and USAID projects.
