Project Description

The general objective of the program is to improve and recover the role of the Francisco Morazan hydroelectric power station (CHFM by its acronym in Spanish) as an effective asset to provide flexibility and integration of variable renewable energy (ERV) to the Honduran electricity system. The specific objectives are: (i) to improve the plant's operational reliability and efficiency as an asset to increase ERV's participation in the National Interconnected System (SNI); (ii) integrate the CHFM to the System Operator (OdS); and (iii) carry out studies to evaluate the increase in its generation capacity.
