Project Description

According to the Inter-American Development Bank, this techical cooperation project will focus on the analysis of policy conditions for the institutionalization and susainability of the Conditional Cash Transfer program known as Grants for a Better Life (Bono Vida Mejor or PBVM per its acronymn in Spanish). It will consist of funding the following activities:

- (i) analysis of the country's capacity to absorb the financing of PBVM with own resources;
- (ii) a proposal for regulations for the operation of the Solidarity Fund seeking to fulfill its original objective of financing the PBVM:
- (iii) an analysis of the institutional environment around the generation of information and its use in making policy decisions;
- (iv) the design of a impact evaluation that analyzes the impact of different periods of duration of the participants in the program;
- (vi) the introduction of analysis of big data for the application of the social registration of the PBVM (through the marking of inconsistent data, for example)
- (vii) the design and development of communication strategy that strengthens the implementation of the program;
- (viii) the implementation of a mechanism to digitalize the information of the care of to the care of early childhood for the verification of health co-responsibility of the PBVM.
