### **Project Description**

The objective of the programme is to enhance the contribution of the financial sector to economic growth by: (i) strengthening financial stability; (ii) enhancing the financial inclusion of firms and individuals; and (iii) improving the financial legal framework.

This operation is the first of a programmatic policy based loan series, which will be made up of two contractually independent and technically linked loans.

The current operation is the first of two consecutive operations that are linked on a technical level, but financed separately as Programmatic Policy-Based Loan (PBP) operations. The first operation is for a maximum amount of US\$100 million, which is consistent with the country's external financing needs (US\$900 million in FY 2015/16 excluding PetroCaribe buyback). This operation would cover 11% of these needs. While the amount and the timing of the second operation will be decided in the corresponding programming exercise based on the country's financing needs, it is expected that the conditionalities identified for the second operation will be met during 2017.
