The purpose of the project is to offer small and medium-sized private clinics financing, via leasing, for the purchase of medical equipment and technology. The project will provide financing to Salud Facil, a non-bank entity that provides leasing services with a commercial strategy that has an important focus on clinics whose patients are from the medium and low socioeconomic level (C- and D). The equipment that clinics will be able to purchase includes ultrasound, X-ray, CT scanners, mammograms, and MRI equipment, which are used to diagnose and treat a wide variety of conditions and diseases, for diverse age and gender populations, including problems during pregnancy, cancers, cardiovascular and coronary diseases among others.
