Project Description

The objective of the Conditional Credit Line for Investment Projects (CCLIP) is to support Mexico in its efforts to improve access to financing in the rural sector. Its specific objective is to increase investments in the rural sector through the support of Fideicomisos Instituidos en Relación con la Agricultura (FIRA) via dedicated credit lines.



Investment Description

- Inter-American Development Bank (IADB)

In order to achieve the objective of the program, the Inter-American Development Bank will subscribe a USD 300,000,000 loan with Banco del Ahorro Nacional y Servicios Financieros, Sociedad Nacional de Crédito (BANSEFI) as a borrower, so that it can fund FIRA. In turn, FIRA will channel such resources to its eligible Financial Intermediaries, in order to increase the supply of credit in terms appropriate to eligible productive units (companies in the agroindustrial, trade and related services with the rural environment) interested in investing in eligible projects (eg. technology acquisition and fixed capital investment) to increase their productivity.
