## Project Description

Project aimed at building climate resilience in the cocoa and apiculture sectors in Nicaragua. This project's objective is to support small and medium-sized Nicaraguan fine cocoa and honey producers in developing greater resilience to climate change. The objective will be attained by facilitating access to: (i) information about climate change in a suitable format; (ii) technological solutions to climate change; and (iii) credit to purchase those solutions.



## Investment Description

- Inter-American Development Bank (IADB)

The project has a total cost of US \$ 2,578,799, of which US \$ 931,246 (36%) will be contributed by the MIF, US \$ 914,256 (36%) by the counterpart, and US \$ 733,297 (28%) through co-financing from the Nordic Fund developmental. The period of execution shall be 48 months and the Disbursements will be 52 months.
