Project Description

According to the IADB, the general objective of the Program is to ensure that children under 36 months of age living in poverty or extreme poverty receive services of adequate quality to support their development. The specific objectives are: (i) to achieve sufficient operational capacity for the provision of services under the National Cuna Mas Program (PNCM); and (ii) to ensure adequate operating conditions for the Comprehensive Child Care Centers (CIAI) that are being supported.
