Project Description

The objective of this operation is to consolidate the achievements obtained in the REDD + preparation process.

To this end, actions will be implemented to help fill the gaps identified in the following areas:

- (i) strengthening of participatory mechanisms for organization and consultation with stakeholders (Participation and Involvement Plan for Actors (PIIA));
- (ii) implementation of the ENBCC, which in the case of Peru is the REDD + Strategy, with national scope;
- (iii) update of the reference level of emissions from deforestation and forest degradation;
- (iv) strengthening of the monitoring system; and (v) establishment of a Safeguard Information System (SIS).
