Project Description

According to the IADB, the general objective of this project is to strengthen the centralized teacher allocation system in Peru. This TC will finance: (i) assessments and improvements in the mechanisms for teacher assignment, (ii) improvements in the front-end technology used to assign teachers including a) further exploration of behavioral strategies to motivate teachers to work in more disadvantaged schools, b) introduction of changes in the teacher assignment platform to enhance user experience to increase transparency and efficiency in teacher assignment, and c) introduction of new technologies, such as artificial intelligence and machine learning, to improve equity and efficiency in the allocation process and increase teacher satisfaction with their final allocation.
