Project Description

The project's general objective will be to improve the learning outcomes of students in the 1st and 2nd cycles of basic education in schools implementing the extended school day, and to implement a pilot offering transportation options for students attending official schools in rural areas. The specific objectives include: (i) developing and implementing pedagogic innovations that support extending the school day in official schools; (ii) supporting the development of schools' management autonomy and capacity, by making school management tools available in the administrative, pedagogic, organizational, and community spheres; (iii) showing results from the impact of these changes on learning outcomes; and (iv) producing documented evidence of the transportation needs of students in rural or sparsely populated zones, and performing a cost-benefit analysis of transportation options as intersectoral inputs for the education policy.
