### Project Description

This project is part of the Complete Caribbean (2010-2017) initiative. In the first phase, the Caribbean Enterprise and Indicator survey was carried out in 2011. In 2013-2014, the Productivity, Technology, and Innovation (PROTEqIN) survey was carried out. To follow up on these surveys, this current project will implement a new survey gathering internationally comparable firm-level data on innovation, use of digital technologies, firm performance, gender and business management practices.

The specific objectives of this project according to the bank are:

1. To define a new sample frame that is representative of the major economic sectors in each country.
2. To define a new methodological approach that includes the development of relevant, comparable indicators, adopting international standards and guidelines for collecting statistical data.
3. To provide statistically significant business environment indicators that are comparable across countries.
4. To collect data on business performance, innovate activities, technology use, management practices, and gender and business climate.
5. To harmonize, as much as possible, the data collection in Caribbean countries to the guidelines of the Oslo Manual and the data collected by the Innovation Surveys carried out in Latin America.

### Investment Description
