#### **Project Description**

The objective of this Technical Cooperation (TC) is to develop an external evaluation of the Sustainable Emerging Cities Multidonor Trust Fund (ESC), which financed, since 2011, technical cooperation projects that implemented the Emerging and Sustainable Cities Initiative (ESCI) methodology. This evaluation will assess the development impacts and results of the operations financed by the Fund, considering aspects, like the fund's relevance and the projects' effectiveness, efficiency, and sustainability. The external evaluation will contribute to identify and generate key lessons learned from the eight years of the ESC implementation (2011 2019), as well as recommendations to consider in the implementation of the new Multidonor Trust Fund for the Development of Sustainable Cities in Latin America and the Caribbean (CIT trust fund). The analysis will be developed in ten different cities where projects funded by ESC were implemented, and it will be conducted through desk review complemented with virtual interviews with key stakeholders (e.g. relevant local authorities that participated in the ESCI implementation process, and IDB members that participated in ESC projects).
