#### **Project Description**

The general objective of this Technical Cooperation (TC) is to finance the design and implementation of inclusive circular economy policies and projects in The Pacific Alliance (PA) to facilitate the transition towards circular municipal solid waste management (SWM) models. The specific objectives of the TC are: i) to support national, sub-national and municipal governments of the PA in the design and implementation inclusive circular economy policies and projects; ii) to increase recycling rates at the national and municipal levels; and iii) to improve the quality of life of informal recyclers by facilitating their integration into formal SWM management programs. The operation will prioritize countries of The Pacific Alliance (PA), namely Chile and Peru.
