#### **Project Description**

The objective of this technical cooperation is to contribute to closing the economic gender gap through the implementation of the Gender Parity Initiative (IPG) and its articulation with activities to recover, create and improve the quality of employment with a focus on gender within the Employment Action Framework with a Gender Approach (MAEG).
