Project Description

According to the Bank's website, the general objective is to support the generation of a 2050 vision for regional energy integration in Mesoamerica, through the expansion of electricity trade, and the promotion of regional electric mobility. Specifically, studies are proposed to support two issues: (i) define a long-term plan for the integration of the Mesoamerican region, through the expansion of the electrical interconnection between the Regional Electric Market (MER) of Central America, Mexico, Belize and Colombia; (ii) the implementation of a corridor of high-speed charging stations.

On the TC Summary, there is also stated that, to achieve the project's objectives, "the region can rely on its abundant, yet unequally distributed, natural resources, first of all hydropower and natural gas".
