## Project Description

The general objective of the program is to increase the efficiency, transparency, sustainability and accountability of the power sector. The specific objectives are: (i) to develop an institutional and regulatory framework; and (ii) to strengthen the corporate capabilities of the sector to supply electricity in an economic, efficient and sustainable manner. This operation is the third and final in a programmatic policy-based series of independently and technically connected loans, in accordance with the Guidelines for Preparation and Implementation for Policy-based Loans (document CS-3633-1). The operation will consolidate the support for the policy reforms and sector decisions envisioned in the program, including the approval of a sector policy with an accompanying legal and institutional framework, a revised electricity tariff that reflects price-setting principles and improvements in N.V. Energie Bedrijven Suriname (EBS)'s corporate capacity and governance.
