## Project Description

The overall objective of the program is to reduce the amount of violent crimes against property (particularly robberies) and against persons (particularly domestic and youth violence) in Uruguay. Specific objectives are: (i) reduce the rate of robberies in Montevideo; and (ii) reduce the rate of domestic violence (partner) and youth (for and against youth) in two pilots in highly vulnerable neighborhoods in Montevideo (Marconi and Casavalle).

The program will have three components. Component 1: Targeted policing strategies for crime prevention. Component 2: Comprehensive crime prevention in highly vulnerable neighborhoods. Component 3: Promotion of the use of scientific evidence in policy-making.

No adverse environmental or social impacts are expected by the IADB. In accordance with the Environment and Safeguards Compliance Policy, the program has been classified as a category “C” operation.

### Investment Description

- Inter-American Development Bank (IADB)

This specific investment program will have a total cost of US\$8 million and will be financed with an investment loan of US\$6 million (75%) from the Bank's Ordinary Capital and a local cash contribution of US\$2 million (25%). The disbursement period will be five years.
