## Project Description

The aim of the project is to improve the competitiveness of agricultural producers in Uruguay. The overall objective of it is to improve the services provided by MGAP (ministry for agriculture) and to continue the changes initiated in improving the management of MGAP for the benefit of producers. The specific objectives will be: i) To deepen the development of Electronic Government and to strengthen the operational management of MGAP; and ii) To continue strengthening the management of food safety, health barriers and laboratory waste management. The operation will build on the actions aimed at strengthening the management of the MGAP carried out by the Support Program for Public Agricultural Management (PAGPA - UR-L1016)
