The program will have three specific objectives: (i) Promote access to quality care for children with disabilities in situations of dependency in educational settings, including the migrant population; (ii) Improve the quality of home care for people in situations of severe dependency and the quality of employment of caregivers, including the migrant population; and (iii) Improve the management and long-term planning capacity of the National Integrated Care System (SNIC),
