Project Description

The proposed transaction consists of a senior secured loan for Eco-Acuícola S.A.C. and Ecosac Agrícola S.A.C. (collectively "Ecosac" or the "Company").

The transaction consists of an A / B Loan for up to US \$ 58.5 million, for a term of 10 years (7 years in the case of loan B) with a two-year grace period and a guarantee on assets acceptable to IDB Invest. The funds will be used to finance: (i) capital expansion investments to increase crop production and the efficiency of existing operations; (ii) for permanent working capital; and (iii) refinancing of financial debt (the "Project").
