## Project Description

The proposed operation contemplates a Senior Secured A/B Facility of up to US\$20 million (the "Facility") to be financed by BID Invest and B lender/s. The Facility will consist of a first loan up to one year, renewable with tenors of up to four years, at the discretion of IDB Invest.

Facility funds will be used to finance Micro, Small and Medium-Sized Enterprises ("MSMEs") through financial leasing operations.

Additionally, technical advisory services are being designed to support the transaction in terms of climate finance and gender and inclusion.
