Project Description

According to the IDB Invest, the financing consists of a Mezzanine debt for an amount of US\$20 million over 7 years, of which US\$4 million will be placed by IDB Invest, which in turn will mobilize US\$16 million from the Blue Like an Orange fund. The use of funds consists of financing the growth plan in Colombia, Mexico and Brazil, in the following areas: (i) technological development; (ii) working capital (iii) capital expenditures and especially (iv) consolidation in the Brazilian market.
