The present transaction consists of a: (i) senior loan in favor of ANC Car S.A. to finance the purchase of approximately 80 vehicles (of which at least 60 will be electric) and solar panels with a nominal capacity of approximately 250 kWp in Costa Rica; and (ii) an uncommitted facility to support the purchase of vehicles (of which 75% will be electric), provide working capital and finance future investments for the expansion and refurbishment of customer service offices in Costa Rica and possibly Guatemala.
