## Project Description

According to the Bank's website, this operation consists of a total financing of up to US\$20 million for a term of up to 7 years to Equirent Vehiculos y Maquinarias S.A.S BIC. The IDB Invest tranche will be up to US\$10 million, US\$5 million being committed and US\$5 million uncommitted. In addition, it will include a tranche of US\$10 million to be mobilized with resources from other financiers. The use of funds in both tranches will be aimed at financing electric vehicles and plug-in hybrid electric vehicles, for their subsequent leasing to companies and individuals in Colombia.
