Project Description

El Proyecto comprende la rehabilitacion, administracion, operacion, mantenimiento y obras complementarias de la carretera CA-9 Sur "A" Escuintla - Puerto Quetzal (entre el Km 60+900 hasta el 102+100). La carretera existente de 41.20 km de longitud es una ruta de doble calzada con dos carriles por sentido. El objetivo principal del proyecto es elevar la ruta a nivel de autopista, mejorando sus condiciones geometricas y de infraestructura operativa, que cumpla con altos estandares de servicio que atiendan los requerimientos de capacidad de transito actual y la demanda esperada, mejorando los niveles de servicio, seguridad y comodidad, promoviendo el desarrollo de la region.

El proyecto Autopista Escuintla - Puerto Quetzal corresponde a la primera iniciativa del Ministerio de Comunicaciones, Infraestructura y Vivienda (CIV) bajo el modelo de Alianzas Publica Privada (APP) de Guatemala.
