The proposed transaction consists of a senior loan of up US\$10 million (the "Loan") from IDB Invest. The Loan has a twelvemonth tenor, is amortized at maturity, and isrenewable for three additional periods of up to 12 months at the discretion of IDB Invest. The project involves funding Progreso to increase its operation (balance) by offering more lending access to Micro, Small, and Medium-Sized Enterprises ("MSMEs") customers, as well as adding new MSMEs to its portfolio.

Additionally, climate-related technical advisory services are being designed.
