It was established in 2010andwas registered with the National Accreditation Council of Guyana (NACG). Texila is Accredited by the Caribbean Accreditation Authority for Education in Medicine and other Health Professions (CAAM-HP) and the Accreditation Commission on Colleges of Medicine (ACCM)

This expansion of the campus consists of the construction of living accommodations for their students and staff (the "Project"). The student hostel will be constructed on the University's existing premises at Providence and the staff housing will be built at Ellenville approximately 2km from the campus. Under the proposed financing IDB Invest will lend up to US\$5 Million.
