## Project Description

The proposed financing to La Société du Rhum Barbancourt S.A., a fifth generation family led company and award-winning rum maker in Haiti since 1862, consists of the following:

- A senior loan of up to US\$2,500,000 that will finance: (a) a solar panel energy project that will generate energy for on premise electricity needs and replace existing diesel run generators; and (b) a reuse bottles facility to enable Barbancourt to:
  - (i) be more cost efficient and reduce reliance on imports, and
  - (ii) reduce its carbon emissions drastically.
- An secured revolving credit facility of up to US\$2,500,000 to finance Barbancourt's working capital needs.
