Project Description

According to the IDB Invest, the transaction involves financing the construction, operation, and maintenance of the Atlas Solar Project, which comprises a photovoltaic park with an installed capacity of 201 MWp / 160 MWac, its transmission line, and associated civil works such as roads, substations, and other necessary infrastructure for energy supply. The project is located in the municipalities of Ibaguè and Piedras (Tolima), approximately 200 km from Bogota D.C. The IDB Invest loan will cover approximately US\$55 million of the total estimated project costs of US\$160 million.
