#### **Project Description**

According to the IDB Invest, The Bahamas Group of Striping Companies is seeking financing for the Eleuthera Road Improvement Project. This initiative aims to construct and rehabilitate key roadways across Eleuthera to enhance connectivity, safety, and the overall travel experience. The project involves the reconstruction and paving of 93 miles of highway and 50 miles of settlement roads, with an estimated cost of US\$100 million.

IDB Invest will lead a financing effort of approximately US\$15 million through uncommitted revolving financing to support the project's execution.
