According to the banks website, the IDB Invest proposes a US\$10 million equity investment in Lottus Education, S.A.P.I. de C.V. ("Lottus"), a leading higher education consolidation platform in Mexico, to finance: (i) capital expenditures in existing educational facilities; (ii) acquisitions of new facilities; and (iii) improvements to its technology platform. Through its operating brands, Lottus offers high school, undergraduate, and graduate programs, both in-person and online. Currently, Lottus serves more than 100,000 enrolled students across 45 campuses and learning centers distributed across 10 states in Mexico.
