### Project Description

According to the bank, the IDB Invest proposes to finance a long-term senior loan of up to US\$12 million to support Rentandes' expansion. The financing will consist of two tranches: (i) the first tranche will be used to finance the acquisition of machinery, industrial equipment, battery electric vehicles ("BEV"), and plug-in hybrid electric vehicles ("PHEV"); and (ii) the second tranche will be used to finance new Euro VI Trucks, subject to meeting eligibility criteria and to the satisfaction of IDB Invest. In this way, the project will promote access for small and medium-sized enterprises to more sustainable technologies, supporting their growth and the transition toward a cleaner economy.
