#### **Project Description**

According to the IDB Invest, the proposed transaction for Invesmar consists of a senior secured loan of up to US\$35 million, with a term of up to 10 years, including a 2 year grace-period. The financing will be structured in two tranches: (i) a committed first tranche of up to US\$25 million aimed at financing the Tahiti lime business, including planting, irrigation, and working capital, as well as the construction of a fertilizer plant; and (ii) an uncommitted second tranche of up to US\$10 million, intended for investments related to additional agribusiness activities.

The project will promote the diversification and expansion of Invesmar's operations, strengthening its sustainable agroindustrial ecosystem and competitiveness in agricultural exports, while also supporting the substitution of imported agricultural inputs and generating employment in rural areas.
