According to the IDB Invest, the proposed financing involves a senior loan to Consorcio Transmataro S.A. to support the construction of the following three transmission lines and associated substations in Peru:

- (i) San Jose - Yarabamba 500 kV (Arequipa)
- (ii) Piura Nueva - Colan 220 kV (Piura)
- (iii) Belaunde Terry - Tarapoto Norte 220 kV (San Martin)

The project's development objective is to ensure the current and future reliability of the national electricity system.
