Project Description

This project provides financing to the City of Mariupol for the following investments:

- Procurement of 64 large capacity Euro-5 diesel buses and bus workshop tools and equipment
- Reconstruction of the bus depot with maintenance and repair workshops
- Expansion of the traffic planning and management system of the dispatch center

The IFC is also proposing to provide advisory services to support the City's efforts to develop a sustainable urban transport system, including fleet planning, urban transport modeling and planning, and environmental and social risk management.

The borrower for this project is Mariupol City Council, and the municipal company Mariupol Tram and Trolleybus Unit, the City's public transportation company, will be the implementation agency.
