Wavemaker's investment strategy is to build a large portfolio, exercise optionality, differentiate with stage (seed) and focus (B2B), and leverage its network."

According to the IFC, the General Partner of Wavemaker SEA Fund III is Wavemaker Pacific Global Partners 3 Ltd (“Wavemaker”). The Fund will be managed by Paul Santos and Eric Manlunas. According to Pitchbook Wavemaker Partners III is an early-stage venture capital fund managed by Wavemaker Partners. The fund is located in Santa Monica, California, and invests in Southern California and Southeast Asia. The fund invests in software and TMT sectors. The fund invests from USD 0.25 million to USD 4 million in 25 to 35 companies.
