Its main businesses are the breeding and farming of pigs, and pig farm services. The proposed IFC investment is an A loan of up to CNY560 million (approximately US\$80 million equivalent). The proposed investment is part of IFC Agribusiness's African Swine Flu (ASF) Regional Recovery Program".
