Private Actors Description

As stated by the IFC, Diners is Ecuador's 7th largest bank in terms of total assets and net loans with market shares of 4.3% and 5.5%, respectively, as of February 2023. The Bank is the market leader in credit card issuance and acquisition in Ecuador by portfolio size, billing, and acquisition.

Diners operates as a digital bank with 6 physical branches located in the largest cities of Ecuador and allied ATM networks with Banco Pichincha and Banred. The Bank has more than 1 million active credit cards and 176,000 affiliated merchants. Banco Diners Club del Ecuador is ultimately controlled by Mr. Fidel Egas Grijalva, a well-regarded lawyer and businessman.
