#### **Project Description**

According to the bank's website, "IFC is considering subscribing to a green/sustainability-linked bond of up to US\$200 million issued by B.Grimm Power Public Company Limited (the "Company" or "BGrimm"). IFC's proposed investment is expected to finance the acquisition, development and construction of renewable energy (RE) projects (wind, solar, storage, hybrids etc.) in the South East Asia region potentially in Thailand, Malaysia and Vietnam and/or other countries ("Project"). The projects to be financed using IFC proceeds have yet to be identified."

IFC, together with parallel bondholder will invest up to US\$150 million in the green or sustainability-linked bond issued by B.Grimm.

#### **Private Actor Relationship**

B.Grimm is listed on the Stock Exchange of Thailand (SET) and is bound by the listing rules in Thailand. B.Grimm Power (Singapore) Pte. Ltd., Mr. Harald Link and B.Grimm Joint Venture Holdings Ltd. are the three major shareholders of the Company, which owns 33.99%, 24.45% and 9.05% of the Company respectively as of December 31, 2021. The rest is owned by institutional and individual shareholders. The Company is rated A (local) by TRIS.

#### **Private Actors Description**

B.Grimm Power Public Company Limited ("B.Grimm" or the "Company") is a leading Thailand-based power developer who has been one of the leaders in small power producer (SPP") gas-fired projects since the start of Energy Generating Authority of Thailand (EGAT) concession bidding in 1995. The Company manages an estimated installed gross capacity of 4GW mostly located in Thailand, with some limited presence in Lao PDR, Cambodia, and Vietnam. B.Grimm sells power under Power Purchase Agreements (PPAs) to multiple offtakers such as Energy Generating Authority of Thailand (EGAT), Industrial Users, Vietnam Electricity ("EVN"), Electricité du Laos ("EDL") and Electricité du Cambodge ("EDC").
