The IFC Loan is expected to be complemented by a B loan of up to €35 million in a second stage. The financing would allow the Company to (i) expand its production facilities by constructing a new 80,000 sqm foam/mattress production factory in Skivjan, in the industrial area of Gjakova, Kosovo; and (ii) finance related equipment and working capital needs.
