## Project Description

According to the IFC, the investment consists of a loan of up to US\$50 million equivalent in BRL (approx. BRL260 million) for IFC's own account to Sociedade de Abastecimento de Água e Saneamento S.A.. The proceeds will be used to finance part of the Company's capital expenditure (CAPEX) plan 2023-2025, geared at improving its water supply and sewage infrastructure contributing to achieving its 100% service coverage objective, growing operational resiliency, enhancing service quality, and increasing efficiency.
