Project Description

As stated by the IFC, the proposed investment is an A loan of up to US\$10 million to support Ferme Jambo in Southern DRC in expanding into irrigated wheat cultivation and milling. The Project will be executed over two phases from 2023-27. Phase 1 (2023-25): investment consisting of (i) farm machinery and irrigation equipment for 1.5 k ha and 4 ton/ hour wheat flour milling line). Phase 2 (2026-27) has assets like Phase 1, financed by US\$10 million. Phase 2 commitment will be contingent on the satisfactory completion of Phase 1.
