As stated on the summary of collaboration project, the International Finance Corporation entered into a collaboration agreement with Bahon Limited, one of three private operators in Bangladesh licensed to provide nationwide wholesale broadband services. This partnership aims to support the company with nationwide fiber rollout, particularly in cities outside Dhaka with smaller populations and underdeveloped fiber footprint, to support mobile network operators in tower fiberization efforts and 5G rollout. With current tower fiberization and home broadband penetration rates well below regional peers, IFC believes that the company has an important role to play in supporting the national digital connectivity agenda in Bangladesh. IFC will work with the company to develop a bankable business plan and to understand applicable E&S considerations, with the overall objective to support the company to expand its rollout of nationwide fiber.
